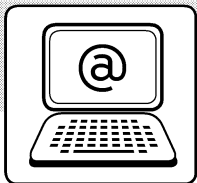

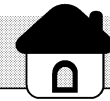
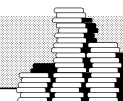

Explanatory Notes:

1. Please indicate, by placing 'X' in the appropriate space overleaf, how you wish your votes to be cast in respect of each of the Resolutions at the meeting. If this form is duly signed and returned, but without specific direction as to how you wish your votes to be cast, the form will be rejected.
2. The 'Vote Withheld' option overleaf is provided to enable you to abstain on any particular Resolution. However, it should be noted that a 'Vote Withheld' is not a vote in law and will not be counted in the calculation of the proportion of the votes 'For' and 'Against' a Resolution.
3. To give an instruction via the CREST system, CREST messages must be received by the Depository (ID number 3RA50) not later than 5 pm (GMT) 13 November 2017. For this purpose, the time of receipt will be taken to be the time (as determined by the timestamp generated by the CREST system) from which the Depository is able to retrieve the message.
4. Any alterations made in this form should be initialled.
5. The completion and return of this form will not preclude a Depository Interest Holder from attending the meeting and voting in person. However, should the holder (or a representative of that holder) wish to attend and/or vote at the meeting, they must obtain a Letter of Representation from the Nominee by contacting the Depository in writing or email UKALLDITeam2@computershare.co.uk
6. Entitlement to submit a Form of Instruction or to seek a Letter of Representation to attend and vote at the meeting and the number of votes which may be cast thereat will be determined by reference to the Depository Interest Register at 5.00 pm (GMT) 13 November 2017. Changes to entries on the Depository Interest Register after that time shall be disregarded in determining the rights of any person to submit a Form of Instruction or to request a Letter of Representation to attend and vote at the meeting.
